Medical, Dental, and Vision

Attain Partners is committed to the health and well-being of our team, and provides three different options of medical coverage for your unique needs. Participants in the high-deductible health plan benefit from an employer-funded Health Savings Account (HSA), and \$0 premium for the employee. Our dental PPO lets you choose any dentist, in or out-of-network, for most preventative procedures at low or no cost as well as referral-free access to specialists. Attain Partners also offers a network of providers to deliver access to high quality vision care, from exams to diagnoses and treatment plans.

Flexible Spending Account (FSA)

Attain Partners offers a pre-tax flexible spending account (FSA) for eligible healthcare expenses such as medical and dental deductibles, co-pays, or prescription drugs; a dependent care spending account for eligible daycare expenses such as day camp, elder care, before- and afterschool care, and in-home daycare; and a transportation spending account from which you may reimburse yourself for eligible transit and parking expenses. Employees who participate in our high deductible medical plan can also access a limited purpose FSA.

401(k)

We support you in investing for your future. Employees can make pre-tax contributions to 401(k) plan accounts through automatic payroll deductions. You may contribute between 1% and 80% of your eligible compensation, up to the IRS annual maximum or \$22,500. Attain Partners matches 100% of the first 4% of your contribution, fully vested on day one.

Life and Disability

Attain Partners provides all full-time employees with basic group term life insurance equal to 1x annual salary up to \$250,000. Additionally, accidental death and dismemberment (AD&D) and short-term and long-term disability insurance are provided. Voluntary life, AD&D, and disability insurance are available for purchase to supplement these programs.

Employee Referral Program

We recognize and reward employee contributions in attracting new team members through employee referral bonuses ranging from \$500 to \$2,000. Send us your best candidates, at all levels, for all divisions, for a variety of roles.

Unlimited Paid Time Off (UTO)

At Attain Partners, we recognize the importance of your personal time and encourage all employees to use this well- earned benefit throughout the year. Use UTO for a variety of needs including vacation, personal or family illness, medical appointments, school, and volunteerism.

Paid Parental Leave

We're proud to offer a competitive paid parental leave benefit, providing four weeks paid leave to new employees and eight weeks paid leave to all full-time employees after their first year. Attain Partners also supplements providerpaid short-term disability (STD) benefits so that employees receive 100% of their salary while on STD leave.

Fertility and Family Building Support

We are proud to offer all benefits-eligible employees up to \$5,000 per year for fertility and family-building services, such as egg-freezing, IUI, and IVF; reimbursement for eligible donor, surrogacy, and adoption services; and virtual holistic health coaching sessions.

Education Reimbursement
